2. **REPORTS AND COMMUNICATION**

2.1 Superintendent Update – Craig Guensler

Mr. Guensler reported that he will be headed to Washington D.C. in early March for the Impact Aid Conference. It looks like Congress has and will continue to make significant changes to this program. The FY2014 8003 Impact Aid Application was submitted this week. The FY2014 8002 Impact Aid Application will be submitted next week.

Mr. Guensler stated that the basement at the District Office was flooded on November 30, 2012 due to heavy rains. Many of our files were destroyed. We have salvaged what we could.

Mr. Guensler has been working with the Solar Company. The organization that they are trying to get the Safe Harbor panels from is looking for a larger project. If we were to add solar to Wheatland Elementary, then we would meet their needs. It would not take up any field space. We would add carports to the back parking lot. To do this we would spend \$267,000 up front and \$267,000 in 6 years. Our savings over the next 25 years would equate to \$2.4 million. Nicole Crabb asked Tami Johnson if the District could expend the additional upfront dollars. Tami said yes, it would not be a problem. It was a consensus of the Board for Mr. Guensler to look into this and to report back. It will go to the Board for a vote at a later date.

Mr. Guensler reported that he and Tami Johnson attended a Governor's Budget Conference this week. He said that it is the best outlook the District's have seen in 7 or 8 years. The Governor would like to send most of the money to District's as unrestricted and allow District's to control their funding. There are plans to pay the \$1.8 billion of the deferrals back to schools. This would be one time money. The new proposed model is going to be what he calls a "by need" model. 35% of our allocation will be based on things like Free and Reduced Lunch counts, ELD Student counts, and other factors. It will likely take until 2021 to fully implement the new funding model.

Although there is an anticipated COLA of 1.65% there will continue to be a 22.27% deficit factor. It appears that we will receive more funding than last year but still 22% less than what we earn. Not all programs will receive the COLA. But all programs receive the deficit. Transportation will be funded like a Block Grant. It will remain the same from now on.

The Federal funding is still very unstable. Congress will have to come up with better plans before March 1 or we could have another fiscal cliff. Mr. Guensler stated that we are happy with most of the news from the Governor's Budget, the reality is we will be funded for 2013/2014 at a lower rate than we were in 2007/2008. More information will come in the May Revise.

Enrollment Report

Current student enrollment is down by 34 students as compared to this time last year. Student Preschool enrollment is at 109.
