**2.1 Superintendent Update – Craig Guensler**

Superintendent Guensler reported that he met with the architect and some of the folks that did the investigation on what we need to do at Bear River. Mr. Guensler stated that they will schedule a Saturday in November to take them through the site without disrupting students.

The 8003 Impact Aid survey date was yesterday. The staff did a great job on the information in Aeries

CBEDS is over and all went well. Again, staff did a great job with the information and submittal to the State.

Mr. Guensler stated that he is not sure what the issue is, but some people are complaining about the tablets at Bear River. Mr. Guensler stated that he finds it interesting that when the District does innovative things and we spend thousands of dollars to make our students better that some parents that should be supporting education are complaining. The second issue is also related to Bear River. A particular parent started a conversation/topic about one particular student beating up on student with special needs. Mr. Guensler reassured the Board that we do not have students picking on any special needs students. In fact, one of the days that the parent alleges that this boy beat up a student, was a day that he was not even in attendance.

Mr. Guensler stated that these things get ridiculous on Facebook and I encourage anyone to tell these folks before they complain in a public fashion like this they should get their facts straight and speak to us so we can investigate it. With the camera system that we have now, there is very little that we can't see.

The Wheatland School District is purchasing the Catapult EMS. This Emergency Management System is a complete EMS for our schools, our District and our community. The system is designed for student and staff safety which is the prime concern in an emergency situation.

We can report and manage real time information about evolving threats, including the location and wellbeing of students and staff during and emergency situation. The system is adaptable to our District and site needs, allowing us full control over who and what information is disseminated and displayed.
