2.1 Superintendent Update – Craig Guensler
Superintendent Guensler thanked Nikki Crabb, Rich Crabb, Jim Evans and Tammy Guensler for their help at Wheatland Elementary on Wednesday May 9th dealing with a suspicious package report. I also want to thank Shari Guzman for coming over to help until Jim got there. As some of you know the package was left in front of the office and was deemed suspicious by the local police and fire department. The Butte County Bomb squad was called by the local authorities and they did what they do. After waiting at least 2 hours for them to arrive and then another 2 plus hours of them talking and working they determined the box was not a problem. It turned out to be a toner cartridge.

As a side note, it was posted on Friends of Wheatland and once we knew what was up, we posted what the issue was. A few parents were not happy that we didn't give them more information or additional information. I want to say publicly that just because a parent wants to know something doesn't mean they have the right to know the information. We posted as soon as we knew the nature of the issue and it had been handled.
