2. REPORTS AND COMMUNICATION

2.1 Superintendent’s Update

- Superintendent Guensler reported the District applied for a kitchen equipment grant of about \$100,000 to replace some of the equipment. We should know more about this one in the spring.
- There was a theft over the 3-day weekend of a catalytic converter from the kitchen delivery van. It will cost about \$600.00 to fix it with our mechanic completing the work.
- Craig handed out information that was shared with him about masking. He wanted the board members to take it home and read it and they’ll talk about it at a later date. He included extras from the CDPH regarding the new mask mandate.
- There’s been a huge spike in the COVID numbers which has led to the cancellation of some sports and the dance. Large gatherings like the Reni Dinner have also been cancelled.
- Superintendent Guensler emailed the new guidelines for quarantining with the board members. He went over the differences in the new guidelines.

2.2 [Enrollment](#)

- The District is at 1341 students enrolled in TK-8th which is 66 more students than this time last year, but 8 less than December.
- There are 147 preschoolers in our preschool classes. That’s 53 more kids than last year.

- Beale has a Play Group that meets every Thursday for parents, and children 0 to 3 years. It's a virtual play group.
- New Families are coming in now and she appreciates the help from the District and School Sites.
- She is hoping for In-Person Events in April to celebrate the month of the Military Child.
- Superintendent Guensler requested they look at the Grass Valley Gate closure as it significantly impacts our transportation.
