2. REPORTS AND COMMUNICATION

2.1 Superintendent Update – Craig Guensler

- Superintendent Guensler started by sharing Yuba County is one of three counties still in the red tier although the tier system is going away on June 15th.
- ➤ Bear River hosted the first vaccination clinic for the county yesterday. There will be two more 1st dose Pfizer and the single J & J shot clinics, plus 3 more 2nd shot Pfizer w/ the single shot J & J clinics all at Bear River School.
- The 8th grade promotion ceremonies are tomorrow at 8:30; 10:30 and 12:30.
- > Superintendent Guensler also wanted to report this year brought the highest GPA ever recorded with a 3.85 coming from Mr. Garren's Homeroom.
- ➤ The fire was pretty crazy on Tuesday. Craig took a moment to thank all the first responders for keeping our school and houses safe on Beale. He also thanked our grounds department for keeping the grass mowed short.
- ➤ We plan to return to a normal school schedule next year without a distance learning model/option, however Craig doesn't have an answer about masks yet. As of right now, employees will probably have to wear masks.
- ➤ The budget will be discussed later in the meeting. Negotiations are still taking place at the State level.
- The Admin team will meet next week to discuss open positions. We will have a need for para-educators and possibly a couple of teaching positions.

2.2 <u>Attendance Report</u> – Craig Guensler

➤ The enrollment was at 1260 when the numbers were run last week. 832 students are in the TK through 5th grades; 364 are middle school students and 64 were in the HbIS program. Overall we are still down 99 students. We should garner this number in the Fall given the numbers we are already seeing for pre-enrolled kindergarteners.
