Superintendent Guensler apologized for the miscue with the LCAP. The company the District uses experienced technical issues that were corrected at the last minute. The corrected version has a total of 106 pages which includes the parent budget overview. The LCAP and the LCFF budget will come back at Thursday's meeting for approval.

This is the final year of a 3 year plan (2017-2020). We expect a complete overhaul for the LCAP template next year.

The plan describes how we serve the students – looking at progress, performance gaps, goals, actions, analysis and plans.

Mr. Guensler publicly thanked Bobbi Abold, from Yuba County Office of Education. She was instrumental in helping with the plan. The County has reviewed our LCAP and believes we have met all the criteria.
