2.1 Superintendent's Update – Craig Guensler

- Superintendent Guensler reported the Reni Rallies are happening this week. Wheatland Elementary had theirs yesterday and it was held outside. Bear River's is tomorrow and will also be held outside. Tomorrow, Lone Tree will hold their rally virtually.

- We have 1351 students enrolled in TK through 8th grade which is 69 more than last year at this time and 2 more than in October. There are 142 preschool students which is up 52 from last year.
