2. REPORTS AND COMMUNICATION

2.1 Superintendent’s Update – Craig Guensler

- Superintendent Guensler had a few items to share. The first was to honor an outstanding teacher. Georgeann Giles passed away this week. We are sending love and prayers to her family. Georgeann began teaching in 1969 and retired in 2003. She started subbing a year after she retired and worked all the way up until the pandemic hit. In total she taught for 50 years. She will truly be missed.
- Starting Monday, we will begin the Hybrid Model with Distance Learning on Monday for one hour through Zoom. The remainder of the day will be spent with students doing independent work and some participating in interventions. Tuesday, the AM/PM 3 hour classes will start. Again, independent learning will take place the rest of the day for AM students and independent learning will be taking place in the morning before the PM classes begin.
- Transportation is available. Schedules are posted on the website. All hands will be on deck to help with transportation.
- Trunk or Treat is scheduled on Halloween which is a Saturday this year. All kids are encouraged to dress up for this fun event.
- Monday and Tuesday of Thanksgiving week, students are scheduled to be in school. However, we will be doing distance learning on those two days to accommodate possible travel plans of students and staff.
- Although there weren’t a lot of people on zoom, Superintendent Guensler asked folks to fill out the Impact Aid survey and Lunch Applications. Impact aid is a huge one tied to the military and we need those forms to be returned to help maintain the level of funding for our programs.

- Today, we closed the HbIS for TK-5th. There is a waiting list for those grade levels. We have a few spots available for 6th through 8th grade.
